BOUNCER POLICY

The City of Torrance allows the use of Inflatable Bouncers and Slides as long as the vendor providing the equipment is on the Approved Bouncer Vendor List.

- The City of Torrance does not allow picnic users to bring their own bouncers to the park.
- Only standard bouncers (19' x 19') or small slides (under 24') will be allowed. Small combos (bouncer + slide) are acceptable as long as the main portion is 19' x 19' and the slide does not extend past 24'.
- The bouncer permit (\$50.00) purchased from Facility Booking does not cover the cost of the bouncer or generator rental.

BOUNCER POWER REQUIREMENTS

- Columbia, El Nido, Hickory, Lago Seco, Paradise, Torrance, Victor, WALTERIA, and Wilson Parks:
 - The City of Torrance does not provide electricity. The bouncer company must bring a generator that doesn't need refueling at the park.
- El Retiro Park:
 - Generators are not allowed. Instead, you must buy an Electricity Usage Permit for \$20 when making your reservation. The bouncer company must bring an extension cord.
- The City of Torrance does not allow any rock climbers, dunk tanks, obstacle courses, laser tag, giant hamster balls, trackless trains, nerf guns, game trucks, or oversized inflatable items.
- Bouncers must be placed in the designated bouncer location, which is provided on the receipt.
- All applications must be received and approved no later than seven (7) business days prior to the event.

INSURANCE REQUIREMENTS

If you would like to use a company that is not listed, they must provide insurance within 7 business days of the event. Liability Insurance in the amount of One Million Dollars per single occurrence and Two Million Dollars aggregate, with endorsement required. A copy of the valid Business License must be on file in order for the business to be on the City's approved list. Vendors may call the City of Torrance Business License at (310) 618-5828. The City of Torrance (3031 Torrance Boulevard, Torrance, CA 90503) must be additionally insured and the following language included:

"THE CITY OF TORRANCE, THE CITY COUNCIL AND EACH MEMBER THEREOF AND EVERY OFFICER AND EMPLOYEE OF THE CITY AND EVERY MEMBER OF BOARDS AND COMMISSIONS, EVERY OFFICER, AGENT, OFFICIAL, EMPLOYEE AND VOLUNTEER."

CANCELLATIONS/CHANGES

Requests for cancellations, changes and/or refund must be submitted in writing to the Facility Booking Office no later than seven (7) business days prior to the event and will incur a 20% administrative fee. The debit/credit card fee is non-refundable. The debit/credit card fee is non-refundable.

INDEMNIFICATION

Arising out of said activities, and as a condition to the use of an inflatable bouncer/slide on City of Torrance property, Applicant/Permittee agrees to release, hold harmless, indemnify and defend the City of Torrance, the Torrance City Council, and each member thereof, members of boards and commissions, and every director, officer, agency, official, employee, tenant and volunteer.
